a US accredited Didactic Program in Dietetics (DPD)		
DPD Course List Form		
I One official sealed transcript per institution attended. An official transcript is also required from		
institutions where courses were taken to fulfill the recency of education requirement.		
Transcripts can be sent electronically from the institution directly to the internship director.		
Three DI Recommendation Forms with Waiver. <b>One is required from a current supervisor</b> . The		
other two can be former supervisors, instructors/professors, and professional mentors.		
 Recommendations from family members or friends will not be accepted.		
<b>Supporting documents for application</b> . If you do not provide documentation for certifications,		
extracurricular activities, or professional memberships, you will not receive credit for them when		
your application is reviewed.
